





# UK CARDIO-IMID Partnership Travel Fellowship Scheme Application Helpsheet

### **Background**

### About the UK CARDIO-IMID Partnership

The UK-wide CARDIOvascular-Immune-Mediated Inflammatory Diseases (CARDIO-IMID) Partnership is an MRC and BHF co-funded collaboration currently comprising >30 UK research centres and/or NHS Trusts. The ambition is for this network to be operationalised into an internationally competitive, precision research driven and sustainable interdisciplinary Partnership, to support high-quality biomedical research studies and targeted therapeutic trials of cardiovascular (CV) disease (CVD) in IMIDs. A key objective of the Partnership is to connect and upskill the next generation of cardio-rheumatology researchers through our early career research (ECR) network.

### **Purpose of Travel Fellowship Scheme**

The Travel Fellowship Scheme supports ECRs to spend time at other centres to carry out a research project or develop a specific research skill. This programme will allow UK CARDIO-IMID Travel Fellows to develop new techniques, skills and expertise as well as cultivating UK-wide collaborations.

### Remit

Your visit must be used to develop a research technique or skills, or to carry out a specific research project. The project must have clear relevance to the field of cardio-rheumatology and should benefit your home institution as well as your own research career. While UK CARDIO-IMID Partnership prioritises domestic lab visits over international placements, overseas visits for UK researchers may be considered if they provide access to skills or expertise not currently available in the UK. The expectation is for the fellowship to be linked to a subsequent grant application to progress the ECR's research plans and/or enable multi-centre collaboration.

# **Eligibility**

To participate in this programme, you must be a member of the UK CARDIO-IMID ECR network and/or hold a current position within the field of cardiovascular or rheumatological research at a centre participating in the UK CARDIO-IMID Partnership. You may be at the pre-doctoral, doctoral or post-doctoral stage of your career, working towards independence.

### What is Funded?

The Travel Fellowship placement is for a maximum of 3-months, depending on the nature of the project and its aims. The funding level varies depending on the expected costs, up to a maximum of £3000 per person.

You can apply for funding to cover your travel and accommodation. The ECR's host and collaborating centres would be expected to support any research expenses, but these could be included if within the £3000 budget. Funding will **not** be provided for:

- Salary costs
- Food and drink costs
- Attendance of conferences or lectures
- Visits that have already taken place, or are underway

### **Assessment Criteria**

Applications are reviewed by the Executive Steering Committee on the following areas:

- Suitability of the applicant track record or potential. Is the applicant committed and competitive with a clear vision?
- Quality of the host lab does it have the relevant expertise and resources to fulfil the ECR's plans?
- Feasibility of the trip are the project aims and schedule realistic?
- Benefit for the home lab will the fellowship enable knowledge-skills transfer for the institute?
- Relevance of the project is there a clear cardio-rheumatology focus?

### Visit Details and Personal Statement

These are the most important sections of your application and should be carefully prepared. You should provide the details of the institute and supervisor(s) that have agreed to host you, in addition to details of your home institution. If you will be supported on your visit by more than one scientist, then please include all the relevant contacts. Your proposed visit dates may be provisional at the time of application, but they should still be precise with regards to calendar year. Successful applicants are asked to confirm their finalised travel dates prior to the visit. Choose a project name that summarises your research plan.

Your proposal should cover the following:

- Background to the proposal
- Aims
- Details of activities/methods
- Outcome

Your personal statement should capture:

- What is your current stage of training and research focus?
- Why are you suitable for this fellowship?
- What are your career ambitions?
- Why is this placement the best way for you to meet the three main aims of your project?

### **Finance Details**

You should take time to think about the costs that you will incur from undertaking your proposed project. It is important that this section is accurate, detailed and clear. You should read the paragraph on 'what is funded?' to help you understand what costs you can include. Please input projected costs into the finance details table provided in the application form. You should use the proposed start and end dates from the visit details section to help you estimate the costs accurately. You need to show your sources to justify your projections, for example:

- Train Tickets: Manchester Picadilly to London Euston, 08:35 on 17/05/2025 (Avanti West Coast); [cost]; quantity x1; www.trainline.com
- Accommodation: Night at Travelodge London Central Euston, [dates]; [cost]; quantity x30; www.booking.com.
- In addition to the cost breakdown, we ask that you provide the total amount that you are asking from the UK CARDIO-IMID Partnership to support your visit. The maximum that you can request is £3000.

### **Submission**

Applications for the 2025 cohort will be open until 11<sup>th</sup> July 2025. Placements for the 2025 cohort are expected to take place between 31<sup>st</sup> July – 31<sup>st</sup> December 2025. Applications are reviewed by the Executive Steering Committee, and applicants will be informed of the outcome by 25<sup>th</sup> July 2025. Completed applications should be signed-off by your host supervisor and submitted alongside a copy of your most recent CV. You are entitled to ask for feedback on your application, but please remember that the Committee's funding decisions are final.

## Post-visit Evaluation

UK CARDIO-IMID Travel Fellows will be expected to provide a scientific report following the stay. We will also ask you to answer a selection of reflection questions and completion of a short survey for feedback to inform future such support and we will also ask you send a few high-quality photographs. We may use information from Travel Fellowship evaluations on the UK CARDIO-IMID website and in other promotional materials

### **Terms and Conditions**

- i. Travel Fellowship funds must be returned in full if for any reason a successful applicant is unable to complete the planned trip.
- ii. The UK CARDIO-IMID Partnership is unable to 'top up' applications in the instance that the actual cost of the trip exceeds the funding awarded by the Partnership.
- iii. Under no circumstances is a UK CARDIO-IMID Travel Fellowship transferable to another person.
- iv. UK CARDIO-IMID Travel Fellowship funds can only be used to support the trip specified in the application form. Successful applicants must seek agreement from the Partnership if any details change after the application has been submitted.
- v. The UK CARDIO-IMID Partnership may request a partial return of funds in the event that a Travel Fellow undertakes a shorter trip than the one detailed in the application form.
- vi. The UK CARDIO-IMID Partnership must be informed about any other funding that a Travel Fellow receives for the purposes of the trip. The Partnership may request for Travel Fellowship funds to be returned if alternative funding covers the same costs.
- vii. The UK CARDIO-IMID Partnership may request evidence that Travel Fellowship funds were used solely for the purposes of the visit. All relevant receipts should be retained by the Travel Fellow for two years.
- viii. Travel Fellows must complete the evaluation process within two months of the end date of the visit.
- ix. All applications will be held on record for five years.
- x. The UK CARDIO-IMID Partnership may contact the home and host supervisors about applications.
- xi. The UK CARDIO-IMID Partnership may publish information about Travel Fellowship visits online and in print using the full name of the Travel Fellow.
- xii. The support of the UK CARDIO-IMID Partnership should be acknowledged in any published work that results from a Travel Fellowship.
